NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of Palisade Park West Metropolitan District shall and hereby does amend the budget for the fiscal year 2024 as follows:

Debt Service Fund \$ 9,114,242 Capital Projects Fund \$20,439,868

BE IT FURTHER RESOLVED, that such sums are hereby appropriated from unexpected revenues available to the District to the Debt Service Fund and Capital Projects Fund for the purpose stated.
